Note #1 – Board of Directors – Attend at least one School Board meeting. Attend committee meetings as CTA Board Liaison. In cases where a committee is shared, each alternate with 50% attendance, so all meetings are covered. Attend Board of Director meetings. Attend the Representative Assembly. Attend special meetings such as one’s own Area meeting, retreats and special board trainings. Deliver Representative Assembly bags. Submit monthly Area written report to the BOD. FEA and NEA Directors will submit a written report when appropriate.

Note #2 – STATE AND LOCAL DELEGATE ELECTION REQUIREMENTS

Q. SUCCESSOR DELEGATES – According to NEA Standing Rule 2C:

A successor delegate shall serve for the remainder of the term of the delegate in whose place the successor delegate is serving.

If a registered delegate leaves the Representative Assembly for an emergency reason, the elected successor delegate may be registered as a voting delegate during the absence of the originally registered delegate. A successor delegate registered in accordance with this provision shall be credentialed to serve as a voting delegate only until the adjournment of the Representative Assembly.
